

Any visitor who is entitled to a discount on his castle admission fee must be able to show relevant, up to date documentation supporting his claim to any such discount.

Access to the castle tour circuit is granted only upon presentation of a valid entrance ticket, regardless of the price paid for the ticket (also applies to visitors who are entitled to a free entry to the castle).
